- Purchasing a truck has allowed the Ranch to not have to pay delivery fees on hay, delivery fees on feed in the winter months, and to freely have access to pick up necessary items that have otherwise involved excess time in coordination of transport.

- Purchasing a truck has allowed us to avoid trip fees in bringing horses to the vet and given us the ability to give our horses ambulator service when needed.

Restricted Donation - Lanning Family(land owners) (Barn and Land)

- In 2018 our land owners (Justin and Nikki Lanning) donated funds solely for the purposes as directed by Justin of building a new barn, fencing in pastures, providing electric and water service to new barn (old barn was torn down as directed by Justin Lanning) and land grading of which directly benefit Freedom Reigns Ranch.

- In 2018 Justin Lanning hired contractors, determined and scheduled work to be completed, and donated funds to Freedom Reigns Ranch. Freedom Reigns Ranch wrote check to contractors for the exact amounts determined and donated from the Lanning Family.

- Freedom Reigns Ranch does not own the barn or fencing as an asset but directly benefits from the barn, fencing, land grading, and water and electric as used on a daily basis to conduct Ranch programs.
